

# RIVERVIEW TOWN BOARD MEETING

## MINUTES FOR MONTH OF OCTOBER 2011

*Minutes to be Approved November 8, 2011*

Meeting agendas were posted at the town's three posting boxes by Clerk Bubolz on October 8, 2011.

The meeting was called to order by Ann Hogan, Town Chairperson on October 11, 2011 at 7:00 p.m. at the Town Hall/Fire Station located at 15471 State Highway 32. Board members present were Chairperson Hogan, Supervisor Trosch, Supervisor Booth, Clerk Bubolz, and Treasurer Smith. All stood for the Pledge of Allegiance. There were approximately 8 townspeople present. The chairperson asked if the Open Meeting Law had been complied with. The Clerk so certified.

### MINUTES

Copies of the minutes of the September 13, 2011 Board Meeting had been given to Board members. A motion was made by Booth and seconded by Trosch "to accept the Minutes." Unanimous approval.

### REPORTS

**FINANCIAL REPORT:** The September Financial Report was reviewed. Ending balance in town regular accounts as of September 30, 2011 is \$256,957.27. Report accepted.

**BILLS AND VOUCHERS:** Approval of checks #11544 to #11588 in General Account. Motion "to pay the bills as presented" made by Booth and seconded by Trosch. Unanimous approval.

**COMMUNICATIONS:** 1) Web site-Forward all 2012 event dates to Chairperson for Economic Development and web site posting.

**ROAD REPORT:** 1). Road Rating System was completed with Bay-Lakes. 2) Grading is almost completed for fall. 3) Crack seal was delivered. 4) Will be working on Mountain Lakes Road.

**FIRE DEPARTMENT REPORT** Riverview Fire Department by Don Seifert: One call. Crooked Lake by Wally Remic: No calls. Have received 16 new radios.

**AMBULANCE REPORT** by Judy Wanner and Supervisor Booth: Budget is proposed to increase \$2238.00 for 2012 due to valuation increase for Town of Riverview.

**LAND USE REPORT:** by Harlan Trosch. 1) Rustic Roads speed Limit is being researched.

**CEMETERY REPORT** by Dick Booth: Motion was made by Trosch and seconded by Booth "to approve proposed \$30.00 opening and closing fee for burials." Unanimous approval.

**ANIMAL CONTROL REPORT** by Mike Rzepka: Two calls.

**RECYCLING REPORT** by Harlan Trosch: Summer hours were discussed. A motion was made by Booth and seconded by Trosch "to approve 2012 Summer Hours for the Recycling Centers from 1:00 p.m. to 5:00 p.m. on Saturday, Sunday and Wednesday." Unanimous approval.

**WISCONSIN TOWNS REPORT:** by Ann Hogan. No report.

**LAKE ASSOCIATION REPORT:** by Harlan Trosch: Milfoil infestation seems to be under control.

**SIX TOWNS MEETING:** by Ann Hogan: Next meeting is October 19, 2011 at Breed.

**OCONTO COUNTY ECONOMIC DEVELOPMENT:** by Ann Hogan: Grant being submitted for Power Washer and Invasive Species.

### OLD BUSINESS:

- a. Gilkey Lake Walkway abandonment was discussed. Because of probable DNR rejection, issue is tabled indefinite.
- b. Motion was made by Booth and seconded by Trosch "to approve Resolution #3-2011 to create a Employee Grievance Procedure for the Town of Riverview as required by Wis. Stat. #66.0509(1m)." Unanimous approval.
- c. Concealed carry law was discussed. Motion was made by Trosch and seconded by Booth "to post signs stating (No Weapons Allowed) in front and rear of Town Hall." Unanimous approval.

Motion was made by Booth and seconded by Trosch "*to approve picnic license for Crooked Lake Sportsman's Club for October 29, 2011.*" Unanimous approval.

Motion was made by Booth and seconded by Trosch "*to adjourn.*" Unanimous consent and meeting adjourned at 7:54 p.m. and the next meeting is scheduled for November 8, 2011 which will follow the 2012 Budget Public Hearing and Special Town Meeting of the Electors which are schedule to start at 6:00 p.m. at the Riverview Town Hall/Fire Station at 15471 Highway 32.
