

# RIVERVIEW TOWN BOARD MEETING

## MINUTES FOR MONTH OF MAY 2011

*Minutes to be Approved June 14, 2011*

Meeting agendas were posted at the town's three posting boxes by Clerk Bubolz on May 5, 2011.

The meeting was called to order by Ann Hogan, Town Chairperson on May 10, 2011 at 7:00 p.m. at the Town Hall/Fire Station located at 15471 State Highway 32. Board members present were Chairperson Hogan, Supervisor Trosch, Supervisor Booth, Clerk Bubolz, and Treasurer Smith. All stood for the Pledge of Allegiance. There were approximately 13 townspeople present. The chairperson asked if the Open Meeting Law had been complied with. The Clerk so certified.

### MINUTES

Copies of the minutes of the April 12, 2011 Board Meeting and Special meeting of April 25, 2011 had been given to Board members. A motion was made by Booth and seconded by Trosch "*to accept the Minutes.*" Unanimous consent.

### REPORTS

#### FINANCIAL REPORT:

The April Financial Report was reviewed. Ending balance in town regular accounts as of April 30, 2011 is \$400,369.59. Report accepted.

#### BILLS AND VOUCHERS:

Approval of checks #11332 to #11369 in General Account. Motion "*to pay the bills as presented*" made by Trosch and seconded by Booth. Unanimous consent.

#### COMMUNICATIONS:

- 1) Web site-None.
- 2) Communication from Northern Oconto County Substance Abuse Prevention Partnership requesting a donation for drug drop-off collection site at Townsend. Motion was made by Booth and seconded by Trosch "to donate \$200.00 to NOSAPP." Unanimous consent.
- 3) No Gypsy Moth spraying is proposed in Oconto County for 2011.
- 4) Recall Election is scheduled for July 12, 2011.

#### ROAD REPORT:

- 1) Sweeping is completed and working on grading.
- 2) Discussed estimate from Brunner Services for work on Rocky Hill Road. Motion was made by Trosch and seconded by Booth "to accept estimate from Brunner Services for Roadside stabilization on Rocky Hill Road in the amount of \$4450.00." Unanimous consent.
- 3) Discussed Thelen Road Bridge replacement, next inspection cycle it will probably be eligible for bridge replacement funds.
- 4) Motion was made by Trosch and seconded by Booth "to authorize the Oconto County Highway to check the Town's signs for reflectivity during the next two years." Unanimous consent.
- 5) Q Gaynor was present and discussed the condition of Donnely Lane. Motion was made by Trosch and seconded by Booth "to have the town haul gravel on the town's part-about 330 feet and grade the road one time to Gaynor's driveway". Unanimous consent.

Motion was made by Booth and seconded by Trosch "*to approve quote from Rick Pouwels for installation of Bulletin Board at Pine Stump Recycling Center.*" Unanimous approval.
