OLD BUSINESS

Rustic Road Update – Application for the Rustic Road was given to Ann Hogan, Town Chair, who then will give to Jo Ann Roy, Lakewood Town Chair to complete. The results from the property owners on old 32 will have to be sent with petition.

Subdivision Ordinance was worked on starting at Section 13 Design Standards will need to get information from Lakewood or another Towns Subdivision Ordinance to complete this section, recommendation will be made at next meeting.

NEW BUSINESS

Driveway and Driveway Connection Permit if a driveway connection permit is obtained from the county or state the town would require a driveway permit at no extra charge so that the information is received on both. It was determined after review of the permits that the appropriate language is already included.

Private Road and Driveway Definitions – if there are 3 or less buildings it is considered a driveway, more than 3 buildings would be considered a private road and must meet or exceed driveway specifications. Recommendation to town board to include this language on the driveway ordinance.

Local Boating Regulations – Town already has everything needed in Ordinance #18 other than to take what is in this Ordinance and change it to the applicable new 2008 Ordinance so the language makes it easier for law enforcement officers.

General Provisions Ordinance Adoption and Code Enforcement Personnel & Process does not pertain to the Plan Commission would be at Town Board level.

ANY AND ALL OTHER BUSINESS

Report from 6 Town Board Meeting-Nothing to report. Paal Hansen went to the Lakewood Zoo and spoke with Casey Ludwig about the recent incident in Ohio. Casey gave a list of all animals in the zoo and will also be giving updates of any additional animals he gets in. A copy was given to Ann Hogan, Town Chair, and to Mike Jansen Oconto County Sheriffs Department.

There maybe some town funding for an ATV ramp need to get some pricing for Time and Material to construct some type of ramp.
